- **b. YouthWorks:** Planning for the Summer YouthWorks program has begun. This year's program should serve approximately 300 youth in Worcester, Webster, and Southbridge. The CMWIB will host a Youth Readiness Training to review the new training from Commonwealth Corporation. This year's program will also include a leadership component sponsored by the United Way, United Families, and the Chamber of Commerce. A group of YouthWorks participants will meet once a week for leadership activities with local leaders from a variety of industry/community sectors.
- **c. Job1 Group:** Staff are waiting on the State's roll out of the WorkKeys program. More information to come.
- d. Connecting Activities: Connecting Activities is a state Department of Elementary and Secondary Education (DESE) funded partnership to help increase student preparation for career readiness through the brokering of internships, part-time jobs, job shadowing, job fairs and other activities designed to help high school students understand the workplace. In Central MA, staff from Worcester Public Schools and the Blackstone Valley Education Foundation help to coordinate the program with 17 area high schools. This year's program is winding down with the school year. Next year's application is due Monday and staff are working on its submission.
- **e. YWIC Member Program Updates:** P. Welch announced that Straight Ahead Ministries is hosting a fashion show following the YWIC meeting. All are welcome to attend.
