## **Meeting Minutes**

- **1. Welcome & Introductions:** The meeting was called to order 2:45PM and all attendees were asked to introduce themselves.
- 2. **Note of Potential Conflicts of Interest & Confirmation of Quorum:** It was announced that a quorum was present and no conflicts were noted at this time.
- 3. Vote:
  - **a. Approval of Minutes of April 9, 2015:** The April 9, 2015 meeting minutes were unanimously approved by a motion by J. Adams and a second.

- 6. Discussion:
  - **a.** Youth Standing Committee WIOA: E. Gagne reported that under the new Workforce Innovation and Opportunity Act (WIOA), youth councils are no longer a mandate. Regions can decide to continue meeting as a Youth Council or opt to develop smaller work committees. After some discussion, the group made the following recommendation.
    - **Vote:** Upon a motion by R. Hooper and a second, the group unanimously voted to approve the recommendation to continue meeting as a Youth Standing Committee.
  - **b.** YWIC/CMWIB Joint Meetings: J. Turgeon informed the group that the CMWIB sub-committees have been asked to do some joint meetings to review each other's goals and identify overlap and where the other committees can support each other. In August, the Cultural Competency Advisory Committee has been invited to attend the YWIC meeting.

## 7. Updates:

- **a. WIOA Youth Update:** E. Gagne reviewed the 3<sup>rd</sup> quarter stats for the local WIOA programs (please see handouts section). It was noted that there are still 3 more months and the programs well ahead of where they should be and staff are confident that goals will be met in all categories.
- b. **YouthWorks:** S. McGauley reported that F. Kartheiser and other advocates from the region are waiting for the budget to pass. The Senate has \$11.5 million and the House has

\$9.5 million. If the Senat budget is approved, there will be a request to use some of these funds for this summer and try to pass a supplemental in the spring for the summer of 2016. The City of Worcester's Youth Opportunities Office is coordinating the Youth Leadership Institute which is a subset of the YouthWorks program. Through the Leadership Institute, a group of youth will spend one day a week at sites throughout the City learning about the community, government, and leadership. Members were asked to submit applications to be a part of this program. YouthWorks starts the week of July 7th and runs until August.
