Per the City Council's request, this information will be shared with groups/individuals, including but not limited to unhoused residents, nonprofit community folks, affordable housing providers, neighborhood associations, the city's immigrant community, the city's disability community, Worcester high school students, homeless shelter providers, racial justice organizations, small business owners, environmental and climate leaders and advocates, parents of folks in public schools, the city's arts community, the city's faith based community, transportation advocates, housing landlords, tenant representatives and groups and all stakeholders.

We also ask the members of the City Council distribute this information to their constituents.
