RESOLUTION OF COUNCILOR KHRYSTIAN E. KING - THAT THE CITY COUNCIL DOES HEREBY RECOGNIZE AVAH ORTIZ'S COMMITMENT AND DEDICATION AS A MEMBER OF THE USA TAP TEAM COMPETING IN THE 2024 INTERNATIONAL DANCE ORGANIZATION (IDO) WORLD TAP DANCE CHAMPIONSHIPS IN PRAGUE, CZECHIA OCTOBER 23-27TH. A CHAMPIONSHIP THAT IS THE EXPERIENCE OF A LIFETIME, BRINGING THE BEST TAP DANCERS FROM ACROSS THE GLOBE TOGETHER TO COMPETE ON STAGE FOR THE WORLD TO SEE. SKILLFULLY BALANCING HER RIGOROUS ACADEMIC SCHEDULE WITH THE DEMANDS OF COMPETITIVE DANCE, AVAH HAS DEMONSTRATED RESILIENCE AND PASSION. WE STAND IN ADMIRATION OF AVAH'S HARD WORK AND THE PRIDE SHE BRINGS TO THE CITY OF WORCESTER. MAYOR PETTY READ THE ITEM AND RECOGNIZED COUNCILOR KING, WHO SPOKE CONCERNING THE ITEM. REVISED LEAD AND COPPER RULE COMMUNICATION

TRANSMITTING INFORMATIONAL COMMUNICATION RELATIVE TO THE REVISED LEAD AND COPPER RULE.

MAYOR PETTY READ THE ITEM AND RECOGNIZED COUNCILOR OJEDA, WHO SPOKE CONCERNING THE ITEM. MAYOR PETTY RECOGNIZED THE COMMISSIONER OF PUBLIC WORKS AND PARKS, WHO RESPONDED TO QUESTIONS RAISED BY COUNCILOR OJEDA. MAYOR PETTY MOVED TO PLACE THE ITEM ON FILE. PLACED ON FILE

THE CITY OF WORCESTER IS CONDUCTING A MANDATORY INVENTORY OF ALL DRINKING WATER SERVICE LINES IN COMPLIANCE WITH THE EPA'S REVISED LEAD AND COPPER RULE (LCRR). THIS INVENTORY MUST BE COMPLETED AND MADE AVAILABLE ONLINE BY OCTOBER 16, 2024, ALLOWING PROPERTY OWNERS TO CHECK THE MATERIALS USED IN THEIR WATER LINES. WORCESTER HAS HISTORICALLY USED PVC, IRON, AND COPPER FOR SERVICE LINES, AND NO LEAD LINES HAVE BEEN FOUND SO FAR. PROPERTY OWNERS WITH UNKNOWN SERVICE LINE MATERIALS WILL BE NOTIFIED AND CAN SCHEDULE INSPECTIONS TO CONFIRM THEIR PIPE MATERIALS. IF LEAD IS DISCOVERED, FINANCIAL ASSISTANCE MAY BE AVAILABLE FOR REPLACEMENT.

DOHERTY MEMORIAL HIGH SCHOOL

RIBBON CUTTING CEREMONY - 10/17



A RIBBON CUTTING CEREMONY FOR THE NEW DOHERTY MEMORIAL HIGH SCHOOL TOOK PLACE ON 10/17, ATTENDED BY MAYOR JOSEPH M. PETTY, DISTRICT COUNCILORS JENNY PACILLO - D1, GEORGE J. RUSSELL - D3, ETEL HAXHIAJ - D5 AND AT-LARGE COUNCILOR DONNA M. COLORIO. THE EVENT MARKED THE COMPLETION AND OPENING OF THE NEW HIGH SCHOOL. AFTER SEVERAL YEARS OF BEING UNDER CONSTRUCTION, THE HIGHLANDERS HAVE THE NEW HOME THEY DESERVE!

THE NEW 425,000-SQUARE-FOOT BUILDING, WHICH CAN ACCOMMODATE OVER 1,600 STUDENTS, OFFICIALLY OPENED ON AUGUST 26. THE CEREMONY INCLUDED THE UNVEILING OF A COMMEMORATIVE PLAQUE, AND WORDS OF DEDICATION FROM STUDENTS, SCHOOL OFFICIALS, AND ELECTED LEADERS. PRINCIPAL JOHN STALEY EMPHASIZED THE SCHOOL'S GOAL OF FOSTERING CREATIVITY, ADAPTABILITY, AND INDEPENDENCE THROUGH ITS ADVANCED FACILITIES AND PROGRAMS.

MAYOR PETTY CELEBRATED THE PROJECT'S COMPLETION, NOTING THAT BUILDING A NEW DOHERTY HIGH SCHOOL WAS ONE OF HIS LONG-STANDING GOALS. AS THE DISTRICT COUNCILOR, ETEL HAXHIAJ ALSO MADE REMARKS ON HOW PROUD SHE IS THAT THE SCHOOL WILL OFFER STUDENTS OPPORTUNITIES MANY CAN ONLY DREAM OF. THE COUNCILOR ALSO MADE A POINT TO MENTION THE THOUGHTFULNESS THAT HAD GONE INTO ENSURING THAT THIS BUILDING IS ENVIRONMENTALLY SUSTAINABLE, SAFE, AND FILLED WITH OPPORTUNITIES WHICH IS EXACTLY WHAT THE STUDENTS IN OUR COMMUNITY DESERVE. COUNCILOR HAXHIAJ, ALONG WITH MANY OTHERS WHO SPOKE, LOOK FORWARD TO SEEING ALL THAT IS ACCOMPLISHED BY THE STUDENTS AND TEACHERS AT DOHERTY MEMORIAL HIGH SCHOOL.





2024 FALL LEAF *COLLECTION* PROGRAM

DO'S & DON'T'S:

DO:

- RAKE LEAVES INTO THE GUTTER JUST PRIOR TO OR ON THE WEEKEND PRIOR TO THE DATE THAT LEAF COLLECTION IS SLATED TO BEGIN IN YOUR AREAL. RESIDENTS ARE ENCOURAGED TO TRACK DPW & P PROGRESS USING AN INTERACTIVE MAP FOUND ON THE CITY WEBSITE AT: WWW.WORCESTERMA.GOV/STREETS/FALL-LEAF-COLLECTION. ADDITIONAL HELPFUL INFORMATION, INCLUDING HOURS OF OPERATION FOR THE THREE DROP-OFF SITES, CAN ALSO BE FOUND ON THE WEBSITE. RESIDENTS SHOULD AVOID RAKING LEAVES INTO THE STREET TOO EARLY AS IT MAY COMPROMISE PUBLIC SAFETY, IMPEDE STREET DRAINAGE, AND IS A VIOLATION OF CITY ORDINANCE.
- MOVE PARKED CARS IN ACCORDANCE WITH SIGNAGE POSTINGS. VEHICLES THAT INTERFERE WITH LEAF COLLECTION WILL RECEIVE A \$ 50 CITATION AND MAY RESULT IN THE INABILITY TO COLLECT THE LEAVES IN THE STREET.
- USE THE YARD WASTE DROP-OFF SITES TO AVOID WAITING FOR LEAF COLLECTION CREWS. THIS IS PARTICULARLY APPROPRIATE FOR THOSE AREAS WHERE COLLECTION IS SCHEDULED NEARER TO THE END OF THE PROGRAM.

DON'T:

- DON'T RAKE LEAVES INTO THE GUTTER TOO EARLY. RESIDENTS SHOULD NOT RAKE LEAVES INTO THE GUTTER UNTIL JUST BEFORE THEIR AREA IS EXPECTED TO BE SERVICED.
- DON'T PLACE BRUSH OR TREE LIMBS CURBSIDE FOR PICKUP. THIS MATERIAL MUST BE DISPOSED AT A YARD WASTE SITE.
- DON'T PLACE LEAVES IN THE STREET AFTER IT HAS BEEN SWEEPED. PLACING LEAVES IN THE STREET AFTER SWEEPING IS COSTLY, VIOLATES CITY ORDINANCE, AND IS SUBJECT TO A FINE. **CREWS WILL NOT RETURN TO STREETS WHERE LEAVES WERE PLACED AFTER COLLECTION.**

- RESIDENTS WHO HAVE QUESTIONS CONCERNING THE FALL LEAF COLLECTION PROGRAM ARE ENCOURAGED TO CALL THE CUSTOMER SERVICE CENTER BY **DIALING 311 OR 508-929- 1300, MONDAY THROUGH FRIDAY, 8 A.M. TO 5 P.M.**
- SIGNAGE WILL BE PLACED 24 TO 48 HOURS IN ADVANCE OF COLLECTION.

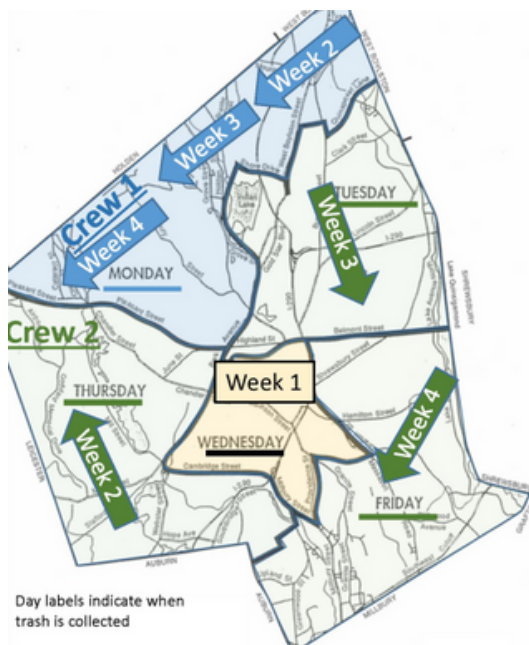

WHEN IS MY LEAF COLLECTION?

2024 Fall Leaf Collection Program

The Department of Public Works & Parks will begin collecting leaves starting Monday, November 4, 2024



Leaf collection will begin in the section of the city that has trash collected on Wednesdays. After collecting leaves in the Wednesday area, leaves will be collected in the Monday, Thursday, Tuesday, and Friday trash collection areas. The leaf collection program is expected to take 4 to 5 weeks to complete, depending on the weather.

Streets will be posted prior to leaf collection to provide advance notification to residents that a **No Parking Ban** will be in effect while leaves are being collected. **ALERTWorcester** will be used to notify neighborhoods of their pending collection. Up-to-date information on where leaf collection is occurring will be advertised in the Worcester Telegram & Gazette and on the Government Access Channel 192. Information can also be obtained from the City's website at www.worcesterma.gov/dpw/seasonal-information/fall-leaf-collection or by calling the Customer Service Center by dialing 311 or 508-929-1300.

LEAF COLLECTION
NO PARKING
7 am to 5 pm

- When you see that your neighborhood is posted with leaf collection signs, you can then rake the leaves into the gutter. You can also use paper, biodegradable leaf collection bags to hold your leaves.
- Do not block catch basins because this may cause flooding during a rainstorm. Do not park on top of piles of leaves as this may cause a fire.
- Leaves will not be collected in locations where residents rake leaves into the street after the street has been swept.
- Only leaves and grass clippings can be collected with leaf collection equipment (NO PLASTIC BAGS OF LEAVES, BRUSH, OR BRANCHES WILL BE COLLECTED. YOU MAY USE BIODEGRADABLE BAGS FOR LEAVES AND GRASS).
- Any brush or tree branches must be taken to the Millbury Street DPW&P Yard Waste Drop-Off Site. Bagged leaves can be taken to the Millbury Street Site, Clark Street (near the intersection of East Mountain Street), or the Chandler Street Site (across from Foley Stadium) on Wednesdays 8:30 - 3, Saturdays 9 - 4. The Millbury Street Site is also open on Sundays from 9 - 4.
