STRENGTHENING CITY-COLLEGE RELATIONS: PROPOSED BALLOT QUESTION ON ENDOWMENT INVESTMENT FOR COMMUNITY IMPACT & ANNUAL DIALOGUES WITH CITY COLLEGES AND UNIVERSITIES

ITEM 12A: ORDER OF COUNCILOR CANDY MERO-CARLSON AND MAYOR JOSEPH M. PETTY - THAT THE CITY COUNCIL PLACE BEFORE THE VOTERS AT THE NOVEMBER 4, 2025, MUNICIPAL ELECTION THE FOLLOWING NON-BINDING BALLOT QUESTION: DO YOU SUPPORT REQUIRING OUR PRIVATE COLLEGES AND UNIVERSITIES TO INVEST 0.5% OF THEIR ENDOWMENT ANNUALLY INTO A COMMUNITY IMPACT FUND TO BE ADMINISTERED LOCALLY TO HELP FINANCE NEEDED HOUSING, ECONOMIC, AND COMMUNITY DEVELOPMENT PROJECTS?
(TABLED UNDER PRIVILEGE - KING APRIL 8, 2025)

AT THE APRIL 15, 2025 WORCESTER CITY COUNCIL MEETING, COUNCILORS UNANIMOUSLY APPROVED A NON-BINDING BALLOT QUESTION FOR THE NOVEMBER MUNICIPAL ELECTION. THE QUESTION ASKS WHETHER PRIVATE COLLEGES AND UNIVERSITIES IN WORCESTER SHOULD INVEST 0.5% OF THEIR ENDOWMENTS ANNUALLY INTO A COMMUNITY IMPACT FUND. THIS FUND WOULD BE USED TO SUPPORT LOCAL HOUSING, ECONOMIC, AND COMMUNITY DEVELOPMENT PROJECTS. THE PROPOSAL WAS INTRODUCED BY MAYOR JOSEPH PETTY AND DISTRICT 2 CITY COUNCILOR CANDY MERO-CARLSON, WHO CITED CONCERNS OVER PROPERTY ACQUISITIONS BY COLLEGES REDUCING CITY TAX REVENUES. MERO-CARLSON EMPHASIZED THAT THIS WAS NOT AN ATTACK ON THE INSTITUTIONS, BUT A RESPONSE TO LOST TAX REVENUE, ESTIMATED AT \$1.8 MILLION.

CITY SOLICITOR ALEXANDRA KALKOUNIS CLARIFIED THAT EVEN IF THE QUESTION PASSES, THE CITY CANNOT LEGALLY COMPEL COLLEGES TO CONTRIBUTE; ANY INVESTMENT WOULD REQUIRE VOLUNTARY NEGOTIATIONS. AT-LARGE CITY COUNCILOR KHRYSTIAN E. KING EXPRESSED SUPPORT FOR THE IDEA BUT WAS CONCERNED ABOUT ITS IMPACT ON ONGOING PILOT AGREEMENT NEGOTIATIONS AND POTENTIAL FUTURE FEDERAL FUNDING CUTS. KING'S MOTION TO REFER THE PROPOSAL TO THE STANDING COMMITTEE ON MUNICIPAL AND LEGISLATIVE OPERATIONS FOR FURTHER DISCUSSION FAILED IN A 6-4 VOTE. DESPITE CONCERNS, THE PROPOSAL PASSED 10-0, WITH AT-LARGE CITY COUNCILOR THU NGUYEN ABSENT.

ITEM 12C: ORDER OF COUNCILOR CANDY MERO-CARLSON AND MAYOR JOSEPH M. PETTY - REQUEST CITY MANAGER MEET ANNUALLY WITH EACH PRESIDENT AND BOARD CHAIR OF THE CITY'S PRIVATE COLLEGES AND UNIVERSITIES, IN AN EFFORT TO CREATE A MORE OPEN DIALOGUE BETWEEN THE CITY AND ITS COLLEGES AND UNIVERSITIES.

(TABLED UNDER PRIVILEGE - KING APRIL 8, 2025)

THE WORCESTER CITY COUNCIL ADOPTED AN ORDER FROM DISTRICT 2 CITY COUNCILOR CANDY MERO-CARLSON AND MAYOR JOSEPH M. PETTY ON APRIL 15TH REQUESTING THAT THE CITY MANAGER MEET ANNUALLY WITH THE PRESIDENTS AND BOARD CHAIRS OF THE CITY'S PRIVATE COLLEGES AND UNIVERSITIES. THE GOAL OF THE ORDER IS TO ESTABLISH A CONSISTENT, FORMAL DIALOGUE BETWEEN CITY LEADERSHIP AND HIGHER EDUCATION INSTITUTIONS. THE PROPOSAL SEEKS TO IMPROVE COMMUNICATION, ADDRESS MUTUAL CONCERNS, AND STRENGTHEN COLLABORATION ON ISSUES IMPACTING THE BROADER WORCESTER COMMUNITY.

THE ORDER WAS INITIALLY TABLED UNDER PRIVILEGE BY AT-LARGE CITY COUNCILOR KHRYSTIAN E. KING ON APRIL 8, 2025, TO ALLOW MORE TIME FOR CONSIDERATION. COUNCILOR KING RAISED CONCERNS ABOUT THE TIMING OF THE ORDER IN LIGHT OF OTHER RELATED PROPOSALS, INCLUDING A BALLOT QUESTION ON COLLEGE ENDOWMENT INVESTMENTS. DURING DELIBERATIONS, COUNCILORS ACKNOWLEDGED THE IMPORTANCE OF OPEN AND REGULAR ENGAGEMENT WITH COLLEGE LEADERSHIP, ESPECIALLY GIVEN THE ECONOMIC AND SOCIAL IMPACT OF THESE INSTITUTIONS. SEVERAL COUNCILORS NOTED THAT ONGOING DIALOGUE COULD HELP PREEMPT TENSIONS AND FOSTER COOPERATIVE SOLUTIONS TO COMMUNITY CHALLENGES.

DESPITE DIFFERENCES OVER RECENT PROPOSALS AFFECTING COLLEGES, THE COUNCIL SUPPORTED THE INTENT BEHIND THE ORDER AND WAS ULTIMATELY ADOPTED, SIGNALING A COMMITMENT BY THE CITY COUNCIL TO MORE STRUCTURED AND TRANSPARENT INTERACTIONS WITH WORCESTER'S PRIVATE COLLEGES. THIS INITIATIVE AIMS TO BUILD TRUST AND SHARED ACCOUNTABILITY BETWEEN THE CITY AND ITS ACADEMIC PARTNERS.

ON APRIL 18, AN HONORARY STREET SIGN UNVEILING CEREMONY WAS HELD AT THE CORNER OF HAWTHORNE STREET AND MAIN STREET TO RECOGNIZE JAIME FLOREZ WAY, CELEBRATING THE CONTRIBUTIONS OF JAIME FLOREZ, SR. THIS HONORARY DESIGNATION PAYS TRIBUTE TO OVER FIVE DECADES OF JAIME'S SERVICE AS A SOCIAL WORKER, COMMUNITY ADVOCATE, AND MARATHONER. SINCE 1986, JAIME HAS USED HIS PARTICIPATION IN THE BOSTON MARATHON TO RAISE OVER \$100,000 FOR LOCAL ORGANIZATIONS SUCH AS THE PIP SHELTER, AIDS PROJECT WORCESTER, EDWARD KENNEDY HEALTH CENTER, AND OTHERS. HIS EFFORTS HAVE DIRECTLY BENEFITED WORCESTER'S MOST VULNERABLE RESIDENTS. JAIME ALSO PLAYED A PIVOTAL ROLE IN ADVANCING LATINO MEDIA, FOUNDING SPANISH-LANGUAGE PROGRAMMING ON WCUW IN 1978 AND REPORTING FOR TVOCERO FOR MORE THAN A DECADE. HE WAS A TRUSTED VOICE DURING THE AIDS CRISIS, HELPING BRIDGE LANGUAGE AND ACCESS GAPS FOR THE HISPANIC COMMUNITY. ADDITIONALLY, HIS WORK WITH THE WORCESTER COMMUNITY ACTION COUNCIL HAS HELPED STUDENTS AFFORD GED TESTING AND PURSUE BRIGHTER FUTURES.

FAMILY AND FRIENDS GATHERED FOR THE CEREMONY, WITH REMARKS DELIVERED BY D4 CITY COUNCILOR LUIS A. OJEDA AND MAYOR JOSEPH PETTY. COUNCILOR KHRYSTIAN E. KING WAS ALSO PRESENT TO HONOR JAIME'S ENDURING LEGACY. JAIME FLOREZ WAY IS AN HONORARY DESIGNATION THAT STANDS AS A SYMBOL OF HIS LASTING IMPACT ON THE CITY OF WORCESTER.

City of Worcester Spring Street Sweeping Has Begun!



The City of Worcester Department of Public Works & Parks began residential street sweeping, Monday, April 7, 2025 in the section of the city that has trash/recycling collected on Tuesday, then progressed to the Friday, Thursday, Monday, and Wednesday trash collection areas. Sign have been posted in neighborhoods in advance of sweeping and will remain in place until the street has been swept.

Arterial streets are swept 11:30 p.m. - 7:30 a.m., Monday - Friday. Residential streets are swept 7:30 a.m. - 4 p.m. Monday - Friday.

Parking Bans will be in effect during street sweepings. Vehicles that interfere with street sweeping will be tagged and may be towed. There is a \$50 fine for cars that are not removed for the street sweeping.

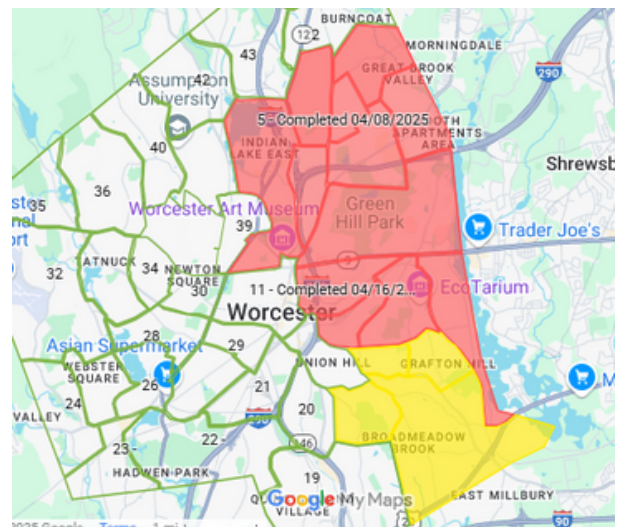
REMINDER: Street Sweepers cannot pick up brush, branches, or yard waste. Residents are advised to bring these items to one of the municipality's yard waste drop-off sites. Violators are subject to fines. Residents and business owners can assist with cleanups by sweeping sidewalk sand and debris into the gutter before street sweepers come to the area. It is also greatly appreciated if residents can sweep in front of walkways, vacant lots, and medians.

Residential street sweeping will take approximately **six to eight weeks to complete**. Area mapping with anticipated upcoming dates for street sweeping can be found on the municipal website.

The Spring Street Sweeping schedule is subject to change. Worcester 311 will regularly post routes on social media. Residents can also sign up to receive updates from ALERTWorcester to receive critical community notifications.
