CITY COUNCIL REVIEWS AND ADVANCES SUMMER 2025 YOUTH EMPLOYMENT INITIATIVES

ITEM : 9.3 DEPARTMENT OF HUMAN RESOURCES - WILLIAM BAGLEY, JR., ESQ., CHIEF HUMAN RESOURCES OFFICER
A. TRANSMITTING INFORMATIONAL COMMUNICATION RELATIVE TO THE CITY OF WORCESTER'S EMPLOYMENT INITIATIVES FOR SUMMER 2025.

AT THE CITY COUNCIL MEETING, AN INFORMATIONAL COMMUNICATION WAS PRESENTED REGARDING WORCESTER'S EMPLOYMENT INITIATIVES FOR SUMMER 2025. VICE CHAIRPERSON COUNCILOR KING INTRODUCED THE ITEM AND RECOGNIZED MAYOR PETTY, WHO EMPHASIZED THE IMPORTANCE OF SUMMER EMPLOYMENT OPPORTUNITIES FOR LOCAL YOUTH. THE CITY MANAGER RESPONDED TO QUESTIONS FROM MAYOR PETTY ABOUT THE SCOPE AND FUNDING OF THE PROGRAM. COUNCILOR OJEDA THEN SPOKE, RAISING CONCERNS ABOUT EQUITABLE ACCESS AND HOW OUTREACH WOULD BE HANDLED. THE CITY MANAGER ADDRESSED THOSE CONCERNS, NOTING EFFORTS TO INCREASE PARTICIPATION ACROSS ALL NEIGHBORHOODS. COUNCILOR KING HIGHLIGHTED THE IMPORTANCE OF MAINTAINING OR INCREASING FUNDING LEVELS COMPARED TO PRIOR YEARS. HE STRESSED THE ROLE OF SUMMER JOBS IN YOUTH DEVELOPMENT AND PUBLIC SAFETY. COUNCILOR KING THEN MADE A MOTION REQUESTING THAT THE CITY MANAGER PROVIDE A REPORT DETAILING THE FUNDING DIFFERENTIAL BETWEEN SUMMER 2025 AND PAST YEARS. HE ALSO REQUESTED THAT THE CITY MANAGER EXPLORE OPTIONS TO CLOSE ANY POTENTIAL FUNDING GAPS. MAYOR PETTY SUPPORTED THE REQUEST AND MOVED TO REFER THE ITEM TO THE MUNICIPAL AND LEGISLATIVE OPERATIONS COMMITTEE. THE COUNCIL VOTED TO REFER THE ITEM ACCORDINGLY. THE DISCUSSION UNDERScoreD A COLLECTIVE COMMITMENT TO SUPPORTING YOUNG PEOPLE THROUGH MEANINGFUL EMPLOYMENT OPPORTUNITIES.



CITY COUNCIL DISCUSSES DEPLOYMENT OF DUAL-STREAM PUBLIC WASTE BINS

ITEM : 9.32 DEPARTMENT OF SUSTAINABILITY AND RESILIENCE - JOHN W. ODELL, CHIEF SUSTAINABILITY OFFICER
A. TRANSMITTING INFORMATIONAL COMMUNICATION RELATIVE TO AN UPDATE ABOUT THE DEPLOYMENT OF 30 PUBLIC DUAL-STREAM WASTE BINS.

AT THE APRIL 29TH CITY COUNCIL MEETING, THE COUNCIL RECEIVED AN INFORMATIONAL COMMUNICATION ABOUT THE CITY'S PILOT PROGRAM DEPLOYING 30 PUBLIC DUAL-STREAM WASTE BINS. DISTRICT 4 CITY COUNCILOR LUIS A. OJEDA RAISED QUESTIONS ABOUT COMMUNITY ENGAGEMENT AND ENCOURAGED COLLABORATION WITH NEIGHBORHOOD NETWORK CENTERS TO HELP SUPPORT AND MONITOR THE ROLLOUT. CHIEF SUSTAINABILITY OFFICER JOHN ODELL EXPLAINED THAT THE PILOT BEGAN WITH 29 BINS INSTALLED IN GREEN ISLAND AND ALONG GRAFTON STREET, BASED ON PUBLIC INPUT AND STRATEGIC LOCATION CRITERIA. DISTRICT 3 CITY COUNCILOR GEORGE RUSSELL EMPHASIZED THE POTENTIAL FOR REVENUE THROUGH ADVERTISING PARTNERSHIPS WITH LOCAL COLLEGES AND INSTITUTIONS, NOTING THE BINS' DESIGN ALLOWS FOR PROMOTIONAL SPACE. COUNCILOR KHRYSTIAN KING PRAISED THE SMART TECHNOLOGY COMPONENT, HIGHLIGHTING THE IMPORTANCE OF COST-EFFECTIVE FILL SENSORS AND CREDITING RESIDENT NOAH ROSE FOR THE IDEA.

JOHN ODELL NOTED THAT DEMAND FOR THE BINS FAR EXCEEDS CURRENT SUPPLY BUT SAID A LARGER ROLLOUT OF 150 BINS IS EXPECTED BY JULY OF THIS YEAR. THE PROGRAM IS BEING FUNDED BY \$500,000 IN TIME-LIMITED FUNDS AND WILL BE SERVICED BY CASELLA, THE CITY'S RECYCLING PROVIDER. PUBLIC ART ELEMENTS WERE INCORPORATED INTO THE DESIGN, WHICH COUNCILOR OJEDA ALSO APPLAUDED. COUNCILOR KING SUBMITTED AN ORDER REQUESTING A REPORT ON HOW THE PILOT WILL BE EVALUATED AND HOW ADVERTISING WOULD BE PURSUED IF SUCCESSFUL.

MAYOR PETTY REFERRED THE ITEM AND COUNCILOR KING'S ORDER TO THE PUBLIC WORKS COMMITTEE FOR FURTHER REVIEW.

RIBBON CUTTING CEREMONY WORCESTER DUAL LANGUAGE MAGNET SCHOOL - 4/29



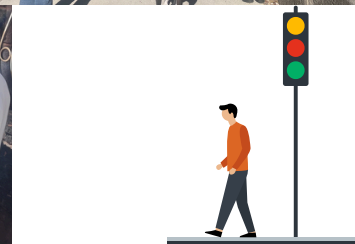

City of Worcester Spring Street Sweeping Has Begun!



The City of Worcester Department of Public Works & Parks began residential street sweeping, Monday, April 7, 2025 in the section of the city that has trash/recycling collected on Tuesday, then progressed to the Friday, Thursday, Monday, and Wednesday trash collection areas. Sign have been posted in neighborhoods in advance of sweeping and will remain in place until the street has been swept.

Arterial streets are swept 11:30 p.m. - 7:30 a.m., Monday - Friday. Residential streets are swept 7:30 a.m. - 4 p.m. Monday - Friday.

Parking Bans will be in effect during street sweepings. Vehicles that interfere with street sweeping will be tagged and may be towed. There is a \$50 fine for cars that are not removed for the street sweeping.

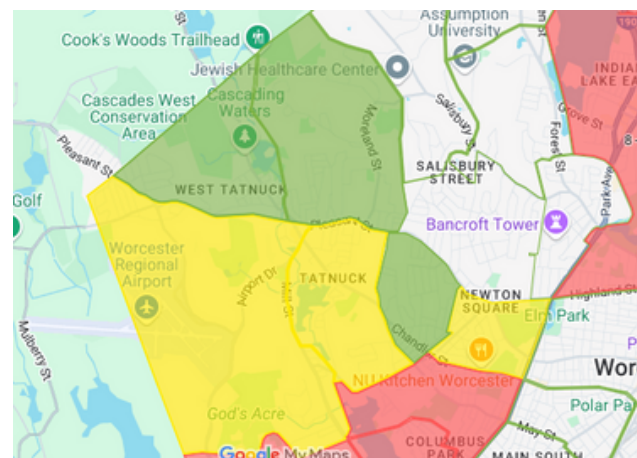
REMINDER: Street Sweepers cannot pick up brush, branches, or yard waste. Residents are advised to bring these items to one of the municipality's yard waste drop-off sites. Violators are subject to fines. Residents and business owners can assist with cleanups by sweeping sidewalk sand and debris into the gutter before street sweepers come to the area. It is also greatly appreciated if residents can sweep in front of walkways, vacant lots, and medians.

Residential street sweeping will take approximately **six to eight weeks to complete**. Area mapping with anticipated upcoming dates for street sweeping can be found on the municipal website.

The Spring Street Sweeping schedule is subject to change. Worcester 311 will regularly post routes on social media. Residents can also sign up to receive updates from ALERTWorcester to receive critical community notifications.
