**ADOPTION OF FISCAL YEAR 2026 - FISCAL** YEAR 2030 HOUSING PRODUCTION PLAN.

COMMUNICATION RELATIVE TO THE TREE **ITEM 10.10B PLANTING UPDATE OF 2025** 

THE WORCESTER CITY COUNCIL HEARD COMMUNICATION FROM THE EXECUTIVE OFFICE OF ECONOMIC DEVELOPMENT REGARDING THE CITY'S HOUSING PRODUCTION PLAN THAT SPANS OVER THE FISCAL YEAR 2026 TO THE FISCAL YEAR 2030. HOUSING PRODUCTION PLANS PROVIDE A STRATEGIC FRAMEWORK TO ASSESS HOUSING NEEDS. ESTABLISH DEVELOPMENT PRIORITIES, AND GUIDE LOCAL POLICIES TO EXPAND AFFORDABLE HOUSING. THE CREATION OF THE HOUSING PRODUCTION PLAN IS A KEY OBJECTIVE OF THE CITY'S STRATEGIC PLAN FOR THE REMAINDER OF THE DECADE. THIS PLAN REFLECTS ROBUST DATA ANALYSIS AND PUBLIC IMPUT TO TARGET POLICY RECOMMENDATIONS ALIGNED WITH WORCESTER'S HOUSING NEEDS. THIS ITEM WAS REFERRED TO THE ECONOMIC DEVELOPMENT SUBCOMMITTEE FOR FURTHER DISCUSSION.

THE WORCESTER CITY COUNCIL HEARD COMMUNICATION FROM THE DEPARTMENT OF PUBLIC WORKS (DPW) RELATIVE TO THE TREE PLANTING UPDATE OF 2025. DPW'S FORESTRY OPERATIONS CONTRACTED THE "DAVEY RESOURCE GROUP" IN 2022 TO CONDUCT A FULL SURVEY OF ALL EXISTING TREES, STUMPS, AND POSSIBLE OPEN PLANTING LOCATIONS IN THE CITY IN ACCORDANCE TO THE WORCESTER URBAN FOREST MASTER PLAN. IN PARTNERSHIP WITH THE DEPARTMENT OF SUSTAINABILITY & RESILIENCE, THE DPW FORESTRY OPERATIONS PLANTED 359 TREES. THE CITY WILL PROCEED THROUGH THE REMAINDER OF 2025 AND 2026 TO EXPEDITE PLANTINGS TO MEET THE CITY'S GOAL OF 2000 NEW PLANTED TREES. THIS ITEM WAS REFERRED TO THE PARKS AND RECREATION SUBCOMMITTEE FOR FURTHER DISCUSSION.

## **JUNETEENTH FLAG RAISING - 6/19**


JUNETEENTH COMMEMORATES JUNE 19, 1865, WHEN THE LAST ENSLAVED PEOPLE IN GALVESTON, TEXAS, RECEIVED WORD OF THEIR FREEDOM-EVEN THOUGH PRESIDENT LINCOLN'S EMANCIPATION PROCLAMATION HAD TAKEN EFFECT MORE THAN TWO YEARS EARLIER. IN WORCESTER, THE BLACK HERITAGE COMMITTEE MARKED THE OCCASION WITH A FLAG-RAISING CEREMONY OUTSIDE THE YWCA CENTRAL MASSACHUSETTS.

ATTENDEES WERE REMINDED THAT WHILE JUNETEENTH WAS A MAJOR MILESTONE IN THE LIBERATION OF AFRICAN AMERICANS, IT DID NOT MARK THE END OF THEIR STRUGGLE. VICE CHAIR KHRYSTIAN KING SPOKE ABOUT THE ONGOING FIGHT FOR EQUAL PROTECTION UNDER THE LAW AND THE LINK BETWEEN HISTORICAL AND PRESENT-DAY CIVIL RIGHTS BATTLES.

MANY ELECTEDS WERE PRESENT INCLUDING MAYOR PETTY, COUNCILOR HAXHIAJ, COUNCILOR NGUYEN, SCHOOL COMMITTEE MEMBER MAILMAIN, CONGRESSMAN MCGOVERN, STATE SENATOR KENNEDY, AND STATE REPRESENTATIVE LEBOEUF.

MAYOR JOE PETTY, VICE CHAIRMAN KHRYSTIAN KING, AND DISTRICT 2 COUNCILOR CANDY MERO-CARLSON ADDRESSED THE CROWD. EDDIE MEKKA WAS BORN IN WORCESTER AND ATTENDED BURNCOAT HIGH SCHOOL WHERE HE GRADUATED AND WENT ON TO ACT IN BROADWAY SHOWS IN NEW YORK CITY. EDDIE IS MOST KNOWN AS "THE BIG RAGOO" IN THE "LAVERNE & SHIRLEY" HIT TV SHOW. EDDIE MEKKA GOT HIS FIRST ROLE IN "FIDDLER ON THE ROOF" WHICH WAS PLAYED AT CLARK UNIVERSITY IN WORCESTER.

# FRIENDLY HOUSE FAMILY SHELTER COMMUNITY MEETING - 6/18



ON WEDNESDAY, JUNE 18, DISTRICT 4 CITY COUNCILOR LUIS OJEDA AND FRIENDLY HOUSE CO-HOSTED A COMMUNITY DISCUSSION ABOUT A NEW FAMILY SHELTER OPENING AT 15 BIRCH STREET. THE SHELTER-FOCUSED EXCLUSIVELY ON FAMILIES—ADDRESSES A CRITICAL NEED IN WORCESTER AMID THE ONGOING HOUSING CRISIS. DISTRICT 5 CITY COUNCILOR ETEL HAXHIAJ ALSO ATTENDED AND SHARED HER EXPERIENCES BOTH AS A COUNCILOR OVERSEEING SHELTERS IN HER DISTRICT AND IN HER PROFESSIONAL WORK WITHIN THE HOUSING AND HOMELESSNESS FIELD. REPRENSATIVE LEBOUEF WAS ALSO IN ATTENDANCE.



DURING THE MEETING, LOCAL RESIDENTS RAISED THEIR CONCERNS, AND FRIENDLY HOUSE STAFF RESPONDED WITH DETAILED ANSWERS AND FEEDBACK. MOVING FORWARD, THEY EMPHASIZED THEIR COMMITMENT TO OPEN COMMUNICATION WITH NEIGHBORHOOD RESIDENTS, NOTING THAT THE SHELTER WILL BE STAFFED 24/7 AND WILL ADHERE TO ALL STATE GUIDELINES.

# **City Hall Parking Updates**

The City of Worcester announced Thursday new parking updates at City Hall, including relocating spaces available for public visitor parking from the garage to Main Street, effective Monday, June 23. In support of operational changes to enhance security, the garage at City Hall will be available for use by authorized vehicles only.

To provide short-term visitors a convenient option, nine new 30-minute on-street parking spots will be established in front of City Hall on Main Street along with two handicapped parking spaces on Franklin Street on the south side of City Hall.

Also starting Monday, June 23, visitors to City Hall will enter through the front entrance on Main Street where they will pass through a security checkpoint and then check in at a visitor kiosk where they will receive a visitor badge. Access through the Worcester Common entrance will be restricted to the public restrooms.

"These parking updates are critical to our newly implemented security measures," said City Manager Eric D. Batista. "This will allow for a single point of entry for visitors to be screened so we have a clear account of who is in the building and what they are doing if an emergency were to ever take place. The new 30-minute parking spots will allow for convenient visitation in addition to the many nearby garages and lots. I want to thank the departments of Emergency Management & Communications, Transportation & Mobility, and the Worcester Fire Department for their interdepartmental work to bring these changes to fruition."

Once the garage restrictions are in place, non-employee visitors who drive to City Hall will need to choose from one of several nearby parking options. In addition to the new 30-minute and handicapped spaces, onstreet parking is also provided on Main Street, Front Street, Federal Street, and other locations near City Hall. Most of these spaces have a 2-hour limit and are metered (\$1.50 per hour).

Longer-term parkers may find one of the many public parking garages or parking lots downtown more convenient. These include municipally operated Pearl Elm garage (900 ft.), Federal Plaza (900 ft.), Worcester Common Garage (1500 ft.), and the McGrath Library lot (1500 ft.). In addition, City Hall is served by the WRTA routes 2, 3, 6, 7, 19, 27, 31, and 33. Many services available at City Hall may also be conducted at the Worcester 311 Customer Service Center at 799 Main St.
