#### ITEM 7A

##### INFORMATIONAL COMMUNICATION RELATIVE TO SIDEWALK AND STREET SELECTION PROJECTS

THE WORCESTER CITY COUNCIL IN ACCORDANCE WITH RULE 33(E) OF THE RULES OF THE WORCESTER CITY COUNCIL, SUSPENDED ITS RULES TO TAKE A REPORT FROM THE STANDING COMMITTEE ON PUBLIC WORKS REGARDING THE SIDEWALK REHAB SELECTIONS FOR FY25 AND FY26 AS WELL AS THE STREET REHAB PROJECT SELECTIONS FOR FY27-28. IN TANDEM WITH THE DEPARTMENT OF PUBLIC WORKS (DPW) AND DEPARTMENT OF TRANSPORTATION & MOBILITY (DTM), DISTRICT COUNCILORS SELECT WHAT ROADS AND SIDEWALKS WILL BE REPAVED. RESIDENTS MAY PETITION THE COUNCIL FOR STREETS AND SIDEWALKS TO BE ADDED TO THE RESURFACING LIST. ONCE THEY ARE ADDED TO THE LIST, DTM AND DPW WILL WORK TO EVALUATE THE CONDITION OF SAID ROAD AND SIDEWALK, AND HOW MUCH IT WOULD COST FOR THE PROJECT. DISTRICT COUNCILORS ARE GIVEN A BUDGET OF HOW MUCH THEY CAN ALLOCATE FOR SAID ROADS AND SIDEWALK SELECTIONS.

##### REPORT OF THE COMMITTEE ON ECONOMIC DEVELOPMENT REGARDING ACCESSORY DWELLING UNITS (ADUS)

THE WORCESTER CITY COUNCIL HEARD A REPORT FROM THE STANDING COMMITTEE ON ECONOMIC DEVELOPMENT REGARDING A COMMUNICATION FROM THE CITY MANAGER REQUESTING THE ADOPTION OF THE PROPOSED AMENDMENT TO THE ZONING ORDINANCE RELATIVE TO ACCESSORY DWELLING UNITS (ADUS). THE PROPOSED ZONING AMENDMENT WILL RECONCILE THE CITY'S EXISTING ADU PROVISIONS WITH THE NEW REQUIREMENTS OF THE STATE LAW (AFFORDABLE HOMES ACT) AND WILL SERVE TO UPDATE CERTAIN OTHER PROVISIONS IN RESPONSE TO THE CITY'S EXPERIENCE OVER THE FIRST YEAR OF IMPLEMENTATION OF THE CURRENT ORDINANCE. UTILIZING ADUS IN WORCESTER IS A POLICY TOOL IN WHICH THE CITY CAN USE TO ADDRESS THE HOUSING NEEDS IN THE CITY. OVER THE FIRST YEAR OF IMPLEMENTATION, 31 ADUS HAVE BEEN PROPOSED, 28 HAVE SECURED PERMITS, AND TWO OF THOSE UNITS HAVE BEEN COMPLETED.

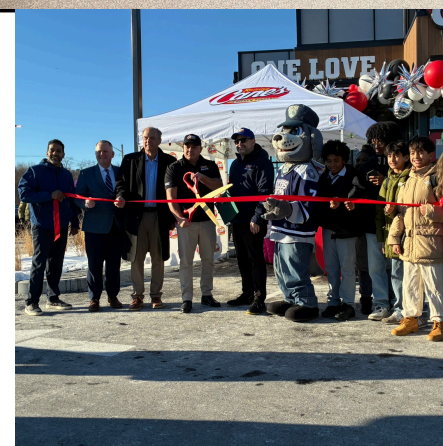


## Events in the Community

### Worcester Announces Permanent Winter Parking Ban in Effect Dec. 1 Through April 30

**WORCESTER, MASS.** – THE CITY OF WORCESTER ANNOUNCED MONDAY ITS PERMANENT WINTER PARKING BAN WILL GO INTO EFFECT DEC. 1, 2025, AND WILL REMAIN THROUGH APRIL 30, 2026 (APRIL 1 FOR RESIDENTIAL STREETS). THE PERMANENT WINTER PARKING BAN APPLIES TO EMERGENCY ARTERIES, WRTA BUS ROUTES, AND STREETS THAT ARE CRITICAL TO THE FLOW OF TRAFFIC. THERE IS NO PARKING ON ONE OR BOTH SIDES OF THE AFFECTED STREET BETWEEN 2 A.M. AND 6 A.M. NOR ANY TIME A SNOW EMERGENCY IS DECLARED.

IN ADDITION TO THE PERMANENT WINTER PARKING BAN, A DECLARED WINTER PARKING BAN WILL GO INTO EFFECT ON ALL OTHER CITY STREETS WHENEVER ACCUMULATING SNOW IS FORECAST. WHEN A DECLARED BAN IS IN EFFECT, PARKING IS ALLOWED ONLY ON THE ODD-NUMBERED SIDE OF OTHER STREETS, UNLESS POSTED OTHERWISE, AND MUNICIPAL PARKING GARAGES WILL BE FREE TO USE UNTIL NOTED FOLLOWING THE BAN'S LIFTING. PARKING ENFORCEMENT—INCLUDING TICKETING AND TOWING—WILL BE ACTIVE DURING A DECLARED BAN, AS ADHERENCE TO PARKING BANS IS CRITICAL TO ALLOW MUNICIPAL CREWS TO KEEP ROADWAYS CLEAR AND SAFE.

WORCESTER 311 IS THE OFFICIAL SOURCE FOR UP-TO-DATE INFORMATION ON WINTER PARKING BANS, PARKING REGULATIONS ON YOUR STREET, AND SNOW COMPLAINTS.

ILLEGALLY PARKED VEHICLES ARE THE BIGGEST OBSTACLE TO EFFECTIVE SNOW REMOVAL EFFORTS. VEHICLES THAT VIOLATE THE WINTER PARKING BAN OR OTHERWISE HINDER SNOW REMOVAL WILL BE TICKETED AND TOWED AT THE OWNER'S EXPENSE. PLEASE SUPPORT THE MUNICIPALITY'S EFFORTS BY PARKING YOUR VEHICLE IN CONFORMANCE WITH THE WINTER PARKING BAN.

#### **WINTER PARKING RULES**

WINTER PARKING BANS ON PUBLIC STREETS FALL UNDER TWO CATEGORIES, **PERMANENT** AND **DECLARED**.

- **A PERMANENT BAN** REMAINS IN EFFECT FROM DECEMBER 1ST THROUGH APRIL 30TH ON EMERGENCY ARTERIES, WRTA BUS ROUTES, AND STREETS THAT ARE CRITICAL TO THE FLOW OF TRAFFIC. THERE IS NO PARKING ON ONE OR BOTH SIDES OF THE STREET BETWEEN 2 A.M. AND 6 A.M. AND ANYTIME A SNOW EMERGENCY IS DECLARED.
- **A DECLARED BAN** IS PUT INTO EFFECT ON ALL REMAINING CITY STREETS WHENEVER ACCUMULATING SNOW IS FORECAST. WHEN A DECLARED BAN IS IN EFFECT, RESTRICTIONS APPLY THAT TYPICALLY ALLOW PARKING ON ONE SIDE OF THE STREET.
