We request the expedited timeline for this project due to the accelerating encroachment of trees and overgrowth from the , adjacent woods and unmaintained areas. This unchecked vegetation not only compromises the field's playability by obstructing sight-line and creating physical hazards, but also significantly increases future maintenance burdens. Delaying action will result in more extensive and costly remediation efforts.

This project aims to revitalize a neglected community asset,

ensuring equitable access for players from Worcester. The restoration will focus on clearing overgrown vegetation, including undergrowth along the fence line, encroaching trees, and damaging vines on the foul ball netting. The warning track, currently obscured and unsafe, will be redefined and restored. Additionally, the bullpen will be rehabilitated and fencing repaired to provide a functional practice area. Crucially, a batting cage and scoreboard will be added, aligning Kendrick Field with the standard amenities offered by neighboring towns and leagues, thus leveling the playing field for local athletes. A lawn tractor equipped with mower, bucket, and rake attachments will help maintain these improvements. This equipment will enable volunteers to efficiently manage the field's upkeep, ensuring the restored areas remain in optimal condition in future vears.
