DISTRICT 1 -BANCROFT SCHOOL FIELDHOUSE Wednesday, December 18, 2019 6:30pm

- · Indian Lake Beach improvements highlighted and appreciated
- Biking very important, walk bike Worcester's work should be incorporated
- CDC-value of parks to public health, incorporate into the community health improvement plan
- Non traditional outreach is needed to reach people-recommend intercept surveys
- WLT & EOEEA & other partnerships should be emphasized
- · Plan should coordinate with complete streets
- ConCom budget and city budgeting becomes a road block
- · Broad Meadow Brook- needs new signs
- Need a creative way to help ConCom use public money to leverage non profit support of ConCom land
- Youth Development & WOR Tech- build relationships to help facilitate work, such as a new sign for Perkins Farm
- Beth- Shore Park is great, coordination needed for next phases, what private support can we find for the other Indian Lake parks
- Morgan/Clayson- safety and accessibility is an issue, Clayson-police have been great, lighting improvements, dealing with the property line will be a phased approach
- Memorials- conservation evaluation, part of action plan, need to capture names on memorials before they disappear

- Dougherty HS replacement -currently on Elm Park land. If the option is to replace it on existing land this will impact both Elm and Newton Hill. If they plan on relocating the HS this will also impact. City should be aware of the plans.
- Undesignated land by the airport is not currently preserved. Makes sense that this land would go the ConCom
- Land behind Chandler Magnet School to Moor Ave could be an opportunity
- Can the lights be left on for street hockey.
- Coes Pond needs an adult swim area, could be a separate facility elsewhere on Coes pond or a larger roped off area for deeper swimming
- Access the water at Leasel pond, Parson Cider Mill and the Old Res. has great recreation potential
- Middle River access along the river, Cutis Pond has no access, could we create an aquatic park where access is by kayak or canoe only. Access islands
- Coes Pond- needs remediation-can we create access to at least view the pond?
- Flood plane issues affect many of the park in this area
- Beaver Brook to Mill to Coes Greenbelt opportunity. Linking these would help uplift the neighborhood
- Daylighting the rest of Beaver Brook
- Shifty SW corner of the road around Coes Pond to be further away from the water edge to create a more park like setting

- Arboretum at Clark University-this areas is only informally protected, no legal protection. Trails in poor shape.
- Tettasit Ridge trail w/ Airport has not formal protection. Needs an MOU with the city.
- Cascades Parks &Boynton need to a masterplan that looks at all the parks together as one. Need one overall management plan. West Tacnic Elementary is continuous to the area. Would be great to connect.
- Connect Moorland Woods to the Old Clarkson Tree Farm
- Beaver Brook needs new playground, old PG was removed to make way for Little League
- Pond level issue at Elm Park



DISTRICT 1 -BANCROFT SCHOOL FIELDHOUSE Monday March 2, 2020

- Emphasize the role public parks play in the environment
- These parks are not just ecosystems but provide public health benefits
- Need a top 10 list of unprotected lands
- Park usage-park security
- Look at MVP to guide acquisitions of new properties
- Enhance- should not mean develop-especially development of sports facilities
- Event not of the city calender
- Lakes & Ponds is having a Fisheries kickoff -look at water quality
- Indian Lake & Institute are the headwater for the Blackstone-need to connect Indian Lake to Quinsig. Village. Need a North/South Trail - Blackstone through Crompton
- Maintain budgets-Current budgets are starvation- resources need to be adequately funded, Parks need to be a strong partner to the other groups and stakeholders
- Indian Lake- history that is lost needs to be included or recognized in some way, partners are need-
- Heat map of density with the open space layer
- Want to see more maps
- Issues around rectangular fields and grass vs turf

- Is synthetic actually recyclable?
- Concerns over parcel 149 149 can be passive only
- Fencing off fields is a problem, makes to field unwelcoming and unaccessible when locked

- Duffy field vs Weatherall Estate-Duffy field makes it seem there is not other uses in the park, that it is a field only and not a park

DISTRICT 2 - GREEN HILL PARK Monday March 9, 2020

- Parks should call for no more deforestation of parks. Open space should remain open space
- Parks should acquire more land
- Permitting needs to be revamped-field space
- Midland School is an elementary school with no green space. They use the park. Park permits often restrict access so there is not time or room for socials
- Leagues are not always using the time that they have permitted. This system relies on negotiation with the leagues for the time that school need. It relies on the personal relationships that can be established between organizations.
- Schools are supposed to have priority over leagues.
- Schools with no green space should have access to fields during the school hours.
- Duffy has a disables people population that uses it during the day.
- Discussion on walking paths
- Discussed need to make more smaller skatable moments in parks
- Need for community gardens and how to advoicate for them. Lot of vacant lots in the city
- Waterways within parks need dredging and have invasive weed issues
- Voice support for the forebay at Institute. This would allow for sediment to be trapped before entering the pond and make it easier for clean out to occur
- District 2 has many buried waterways-critical need to preserve open brooks that remain
- Dickson and celdon street 2 lots that could allow for circumnavigating Green Hill without going through the golf course
- Skateparks need to be like little leagues. Couselor Rosen has advocated for renovation of the Grenn Hill Park skate park.
- Skating at the Oval could be open on certain days, allowing access at certain time, in conjunction with an event.
- Alley next to the Oval could have a skate moment in it
- Skate monets at all parks
- Pop up skate events-sponsorship through Vans or Converse, would help create economic drive
- End of Lincoln-very difficult for people and cyclist to get across. Notice the entrenched foot paths
- Do colleges help as much as possible?

Q1: Are there any specific parcels that have been targeted? What is plan in terms of targeting parcels? What is the city's ultimate objectives in acquiring parcels?

All parcels that we have identified in previous open space plan, we worked closely with the Great Worcester Land Trust, Mass Audubon on property that are in and around ex. city park. We added the parcel with those parks. Another thing we are also looking at somewhere that has density neighborhood, food resource, the ability for farmers, community gardens, etc.

Q2: How much spaces will you need for them? It doesn't matter on that. Small parcels, a couple of thousand square feet or much larger space are all good.

- Also looking for parcels that have no useful building component to it, and maybe beneficial to the park system, maybe something we can use for.
- Looking for environmental justice area as the major drive of parcels as well. Maybe another playground or community gardens.
- In terms of someplace that have ex. structures, we may value the property first. We search for lots of parcels that are abandoned, overgrown, with subdivision that wasn't built out. Seeking the balance of the need for academic grown as well.

Q3: About "Converting underutilized properties", how to gather the utilization informations to identify the underutilization?

- what we talk about underutilized in regarding to the space with renovation that could offer more opportunity. This kind of park renovation is based on neighborhood needs and wants, overall city demographic needs and wants, and we try to balance those as we move forward.
- The data is based on permits, no general review of sites. All the data was took from neighborhood when we do the Master Plan. The league helps us to manage the space, that's the primary data source. Also work with other departments to double check the data.
- The data accuracy. Prefer to have more transparency of the Permitting process and data gathering. Such as post on-line, having more channel to get feedback.

Q4: Other than neighborhood, how about public school usage?

This will also be calculated.



DISTRICT 4 - CROMPTON PARK Monday, December 21, 2020 6:30 pm

Notes:

- Elm Park didn't have a master plan before, looking forward to have that master plan.
- Needs of elevating Heat Island Effect and generate community gardens. Such as tree canopy not only as the street tree, but also in open space and parking lots as shelter.
- Circulation of water also needs to be consider.
- Micro-lots are good consideration, but have some issue of buying out, hard to clean and snow removal.
- Will the State representatives for the city of Worcester think of the propose of a new chapter 61, which is suited to micro lots? This keeps the property privet, but encourage the privet property that has extra parking lots provide the parking to the public and refine it.
- Consider all State grants.
- To pick up where the neighborhood volunteers to start build a trail system that were user-friendly. Heavy crew use the trail at summer, it's good if the trail get more user-friendly lines.
- Working on a foot traffic corridor of connection between Millbury St. and the Blackstone Bike Way Parking Lot.
