**#1. - The Elev spec section included in Addenda #1 references an Alt #1 for a new hydraulic cylinder / piston assembly and new car buffers. However, there is no mention of any alternates for the GC and the elev FSB results did not include any #'s for an alternate. Does this project have alternates for the GC?**

**Answer: No alternates are included in this bid.**

**#2 - The Elev spec section included in Addenda #1 states that the elev contractor is to supply a P&P bond. Is this bond to be made out to the owner in addition to the GC bonds to the owner? Typically the bonds for FSB are at the GC's discretion.**

**Answer: The elevator file sub-bidder is not required to provide a payment and performance bond unless the GC, under their discretion, so requires.**
