- 4) **All prices are to be firm F.O.B. Delivered Destination, City of Worcester, Massachusetts, unless otherwise indicated by the City. Time reserved for award is thirty days.**
- 5) In case of error in the extension prices quoted herein, the unit price will govern.
- 6) It is understood and agreed that should any price reductions occur between the opening of this bid and completion of any delivery of any order, the benefit of all such reductions will be extended to the City.
- 7) The City of Worcester reserves the right to reject any and all bids, wholly or in part, and to make awards in a manner deemed in the best interest of the City.
- 8) Awards will be made to the bidder quoting the lowest net price in accordance with specifications.
- 9) The bidder to who a contract is awarded guarantees to the City of Worcester all equipment, materials and/or workmanship for a period of one (1) year after final inspection and acceptance and shall replace promptly any defective equipment, materials and/or workmanship required without additional cost to the City.
- 10) It is understood and agreed that in the event of failure on the part of the bidder to indicate date of delivery and/or completion, delivery and/or completion will be made within twelve (12) days from date of purchase.
- 11) The Bidder must certify that no official or employee of the City of Worcester, Massachusetts is pecuniarily interested in this quotation or in the contract which the bidder offers to execute or in expected profits to arise therefrom, unless there has been compliance with provisions of G.L. - Made from high density polyethylene (HDPE)
- Can withstand temperatures ranging from -40 deg. F to 130 deg. F
- Volume – 22 to 24 gallons
- Weight – approximately 5 pounds.
- Weight capacity – approximately 175 pounds
- Drag ribs on the bottom of the bin
- Four (4) drainage holes
- Spill retention channels on bottom
- Color, Dark Green/Forest Green or equivalent
- Set-Out Container will have a ¼ inch hole drilled through one handle so that the Container and Lid can be attached
- Hot stamp custom printed on one (1) side

Open Vented Lid for Recycling Set-Out Container

- Made from high density polyethylene (HDPE)
- Can withstand temperatures ranging from -40 deg. F to 130 deg. F
- Will fit the opening for the recycling set-out container above
- Lid will be domed and vented with openings to allow recyclables to be placed into the recycling container without removing the lid

- Lid will click in place and be easy to secure and remove from the recycling set-out container.
- Lids will have a ¼ inch hole drilled through one handle so that the Container and Lid can be attached.
- Color, Dark Green/Forest Green or equivalent
