- Vehicles must be 2014 – 2022 models
- Vehicles mileage must not exceed 150,000 miles
- Vehicles capacity minimum 7
- Vehicles must have operating air conditioning
- Buses must meet Massachusetts State 7D School Vehicles specifications, including
  - Interior school bus light indicator
  - Audible backup alarm
  - Child reminder system
  - Capacity must not exceed 10 passengers
- Acceptance will be based on successful inspections
- The bid price must include all fees i.e., all delivery costs and dealer preparation.
