In order for all contractors to bid on equal footing: what is the quantity and type of anchor (product & manufacturer) to be used?

City Response: At Addenda #2, engineer's response to Contractor Question# 6: **DELETE**, "Existing floor anchors will be required to be salvaged and reset, or new equivalent anchors to be provided", **INSERT**, "12 (twelve) concrete floor slab anchors will be required to be salvaged and reset. If new anchors are required, provide 12 (twelve) concrete floor slab anchors at existing locations. Basis of Design, Jayco Sports, Floor Plate Assembly FP-89, or equal."

The Bidder is required to provide a bid for each Alternate listed below. If selected by the Owner, the Alternate(s) will be added/deducted to the total Base Bid price to determine the low bidder.

ALTERNATE 1: Contractor to complete half (½) of the Floor Upgrade Scope through August 18, 2023, and remobilize between June 24, 2024 and August 31, 2024 to complete the remaining scope. Coordination with DCU Center/ASM Global Operations, and City of Worcester representatives is required to establish a final schedule.
