## 1. Replace the Scope of Services Subsection of the RFP with:

## "Scope of Services

- A. Project Administration and Community Engagement:
  - a. Kick off and bi-weekly team meetings, and minutes of same.
  - Contract with up to 2 Community Liaisons from Worcester area serving vulnerable populations to assist with community education, engagement, and outreach.
  - c. Engage and Involve the Community.
    - i. Develop and implement a detailed and effective project communication plan.
    - ii. Educate community about the project and its benefits.
    - Seek ideas for potential 2 Resilient Community Spaces in the designated areas with priority populations, explore feasibility of additional locations.
    - iv. Once two locations are identified, deeply engage the community in developing ideas for the design of the Resilient Community Spaces (2) that meet community needs.
    - v. Build a constituency of project supporters with a goal of them becoming involved in project implementation, take ownership of the process, and learn and share their experience.
- B. Urban Design of Two Community Resilient Spaces, and associated public engagement
  - **a.** Project Management associated with selecting and designing outdoor community resilient spaces with significant public engagement component.
  - **b.** Develop concept plans for the chosen two properties, using meaningful community engagement.



- C. Design and Implementation of Two Miyawaki Forests, and associated public engagement
  - c. Project Management.
  - d. Develop Miyawaki Forests planting plans and purchase associated plants<sup>1</sup>.
  - e. Install the plants with the assistance of the community (expected in the spring of 2024).
  - f. Provide short-term and long-term management plans.

They are expected to be no less than 10,000 SF in size and likely located in a presently or formerly paved area (such as a large parking lot).
