Question #1: How many plants and what types will be planted on site? I see the detail just doesn't give quantities.

Answer #1: Miyawaki Forest planting (purchasing the plants and planting them) is NOT part of the bid scope, and will be done by the project team and community volunteers.

Question #2: Also for the bed preparation I see owner is supplying all materials. Contractor is responsible for pick up? If so where is materials located?

Answer #2: Woodchips will be provided for free by USDA ALB Site at the Worcester County Jail, but will need to be delivered to the site and spread out by the winning bidder. Compost will be provided for free and delivered by the City to the site, but will need to be spread out by the winning bidder.

# **Project Scope Summary:**

Preparing two sites for planting of Miyawaki Forests (excluding planting work itself), installing fencing and associated work:

Unless otherwise noted, the contractor is responsible for the materials.

#### 1. McGrath Municipal Parking Lot:

- a. 6,500 SF area preparation for a Miyawaki Forest planting\*, including saw cutting & removing asphalt pavement, removing, and resetting curbs, pavement markings, 2' wide infiltration trench, 4' stone dust path, preparing the planting bed (till, woodchips\*\* and compost\*\*\*) and associated work.
- b. 410 feet of 4-ft fencing and 2 gates to be purchased and installed.
- c. See attached Layout and Materials Plan and Site Details and Construction, for details, dated March 7, 2024, by BSC Group.
- d. See attached Technical Specification for McGrath Lot Site Improvement, dated February 15, 2024.

## 2. Plumley Village Site:

- a. 8,000 sf area preparation for a Miyawaki Forest planting\*, including preparing the planting bed (till, woodchips\*\* and compost\*\*\*); 2' wide infiltration trench; installation of staked logs for slope stabilization, and associated work.
- b. 450 ft of 4-ft fencing and 2 gates to be installed.
