With reference to our bid request relative to the above subject, please refer to the changes/modifications/clarifications to the original proposal request.

- **PLEASE SEE BELOW QUESTIONS RECEIVED AND RESPONSES FROM CITY**

1. One of the areas to price out is per acre. This is difficult to come up with a price when not seeing what is on the acre. There could be a large amount of debris and trash tires etc. or a small amount. To be able to give an accurate bid what is the city looking for is it just labor and equipment and dump costs are extra or everything included in the per acre cost?

Answer: Please see revised pricing page. Item 10 has been changed from a per acre cost to an hourly rate for labor and for trucking to Wheelabrator in Millbury, MA Bidders are instructed to use the attached pricing page with bid submission. This hourly rate shall include the cost to remove debris from the site and to truck debris to the Wheelabrator disposal facility at 331 Southwest Cutoff in Millbury. Tipping fees shall still be accounted for in item # 3.

Bidders are requested to acknowledge and/or include this addendum with submission. All other terms, conditions, and specifications remain unchanged.
